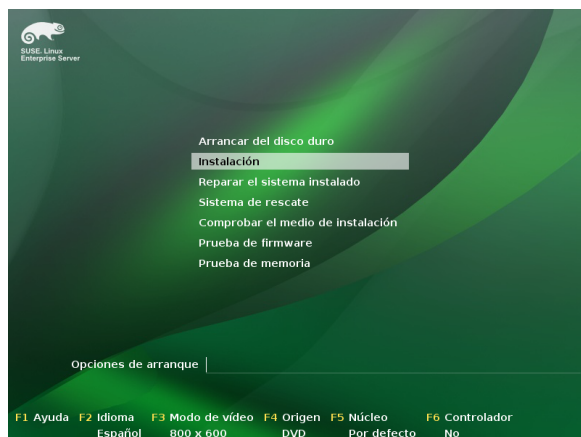
Requisitos mínimos del sistema

- Procesador Pentium® III a 500 MHz o superior (se recomienda Pentium 4 a 2,4 GHz o superior o cualquier procesador AMD64 o Intel® EM64T)
- 512 MB de RAM física (se recomienda 1 GB)
- 2 GB de espacio disponible en disco (se recomienda una cantidad superior)
- Resolución de pantalla de 800 x 600 (se recomienda 1024 x 768 o superior)

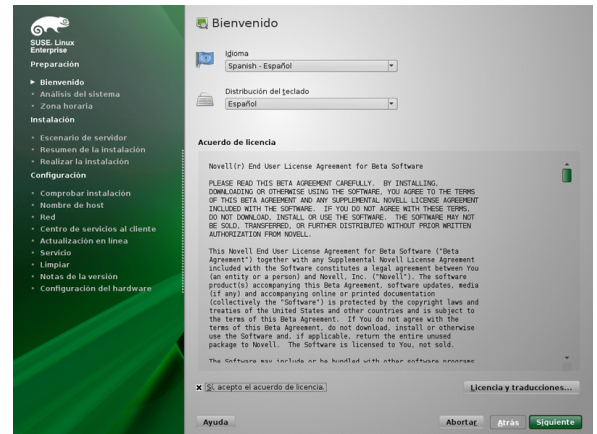
Instalación de SUSE Linux Enterprise Server

Siga estas instrucciones si el equipo no cuenta con un sistema Linux o si desea sustituir un sistema Linux existente.

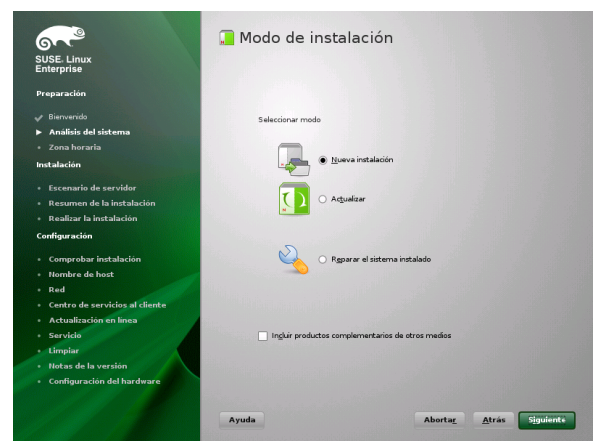
1. Inserte el DVD de SUSE Linux Enterprise Server en la unidad y arranque el equipo para que se inicie el programa de instalación. En equipos con BIOS tradicional, verá la pantalla de arranque gráfica que se muestra a continuación. En equipos con UEFI se emplea una pantalla de arranque no gráfica. Se admite el arranque seguro en equipos con UEFI.



2. Seleccione *Instalación* en la pantalla de arranque y pulse **Intro**. Se cargará el



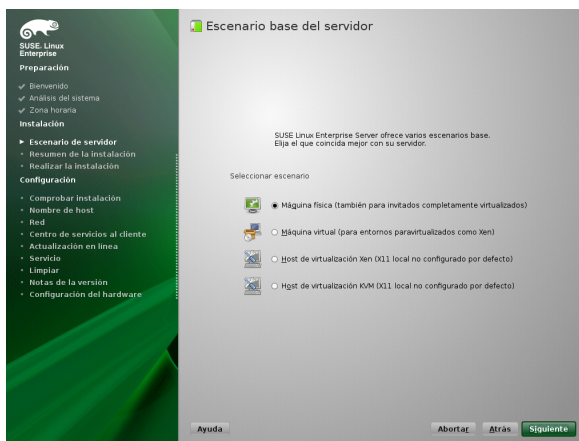
3. Seleccione el idioma que se debe usar durante la instalación y para el sistema instalado.
4. Lea el acuerdo de licencia y haga clic en *Sí, acepto el acuerdo de licencia*. Haga clic en *Siguiente*.



5. Indique si desea realizar una *Nueva instalación* o una actualización a partir de una versión anterior de SUSE Linux Enterprise Server. Haga clic en *Siguiente*.



6. Seleccione el reloj y la zona horaria que se debe utilizar en el sistema. Haga clic en *Siguiente*.



7. Decida si desea realizar la instalación de SUSE Linux Enterprise Server en una *Máquina física*, como un invitado virtual en un equipo XEN seleccionando *Máquina virtual* o como un host de virtualización que pueda ejecutarse en otros equipos virtuales con las opciones *Host de virtualización XEN* o *Host de virtualización KVM*. Haga clic en *Siguiente*.

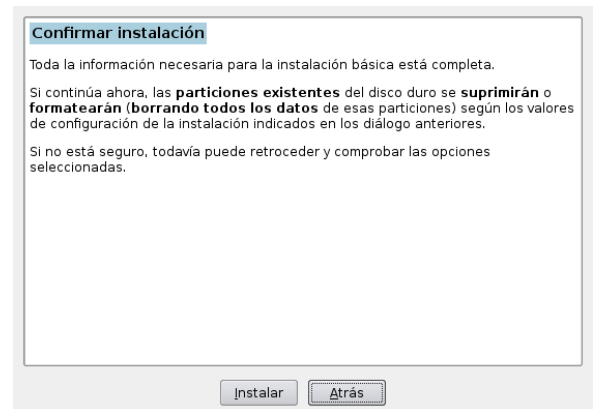


8. Use la pantalla *Configuración de la instalación* para ver una serie de opciones de instalación y partición y, si procede, cambie las opciones que desee.

La pestaña *Resumen* contiene opciones básicas que, en ocasiones, necesitan que se

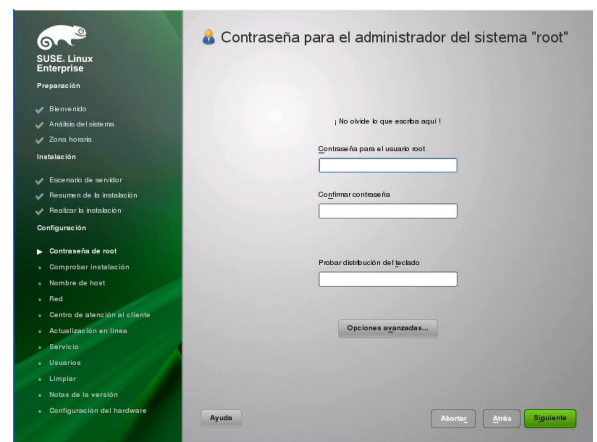
intervenga de forma manual en las situaciones de instalación más habituales. La pestaña *Experto* contiene opciones de configuración avanzadas.

9. Haga clic en *Aceptar* para aceptar los acuerdos de licencia.



10. Comience la instalación con la opción *Instalar*.

Después de realizar la configuración básica del sistema y de instalar todos los paquetes de software seleccionados, la instalación de SUSE Linux Enterprise Server arranca en el nuevo sistema Linux. Después de rearrancar, se mostrará la siguiente pantalla:

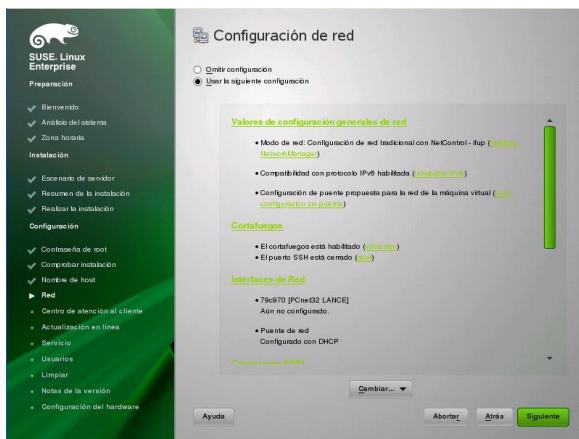


11. Escriba una contraseña para la cuenta del administrador del sistema (llamado usuario *root*).

¡No olvide nunca la contraseña del usuario *root*! Tras introducirla aquí, no podrá recuperarla. Sólo se puede restaurar con ayuda administrativa. Haga clic en *Siguiente*.

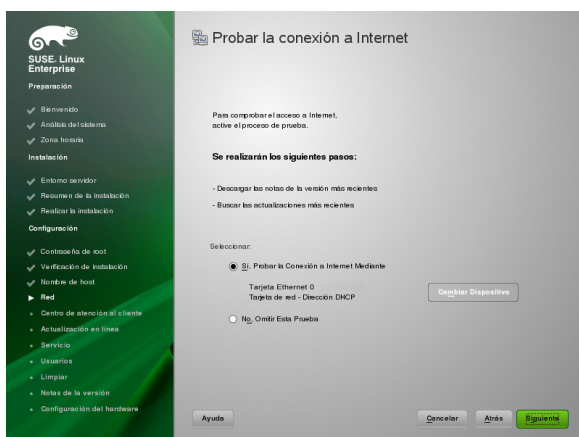


12. Introduzca un *Nombre de host* para el equipo y el *Nombre de dominio* DNS al que pertenece. Haga clic en *Siguiente*.



13. En la pantalla *Configuración de red*, consulte o modifique las conexiones de red del sistema.

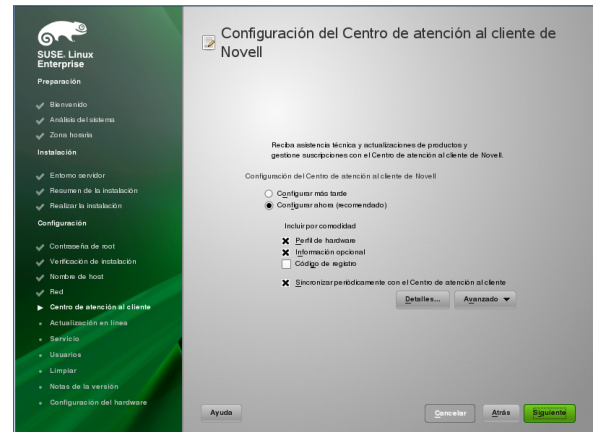
Si tiene dispositivos de red (por ejemplo, tarjetas de red o inalámbricas, una conexión DSL, un adaptador RDSI o un módem) es recomendable configurarlos en este momento, porque una conexión a Internet permite que SUSE Linux Enterprise Server recupere las actualizaciones disponibles y las incluya en la instalación. Haga clic en *Siguiente*.



14. Para comprobar la conexión a Internet, haga clic en *Sí, probar la conexión a Internet*. Con esta opción también se comprueban las

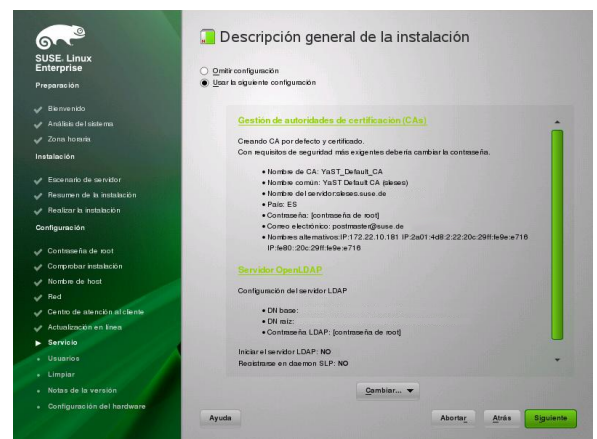
últimas notas de la versión de SUSE Linux Enterprise Server. Haga clic en *Siguiente*.

15. Podrá ver los resultados de la prueba en la pantalla *Probando la conexión a Internet*. Haga clic en *Siguiente*.

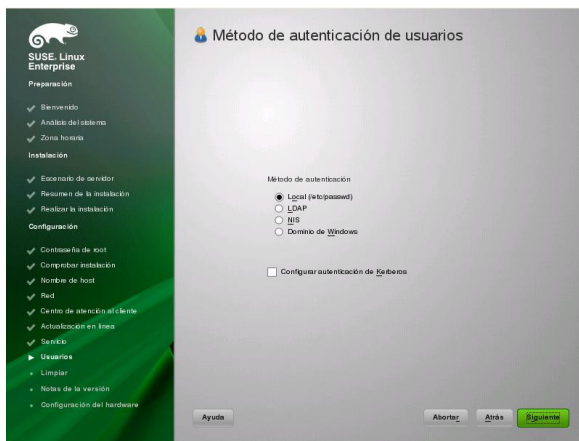


16. Habilite las actualizaciones en línea del sistema en la pantalla *Configuración de Novell Customer Center* mediante *Configurar ahora* → *Siguiente* → *Continuar*.

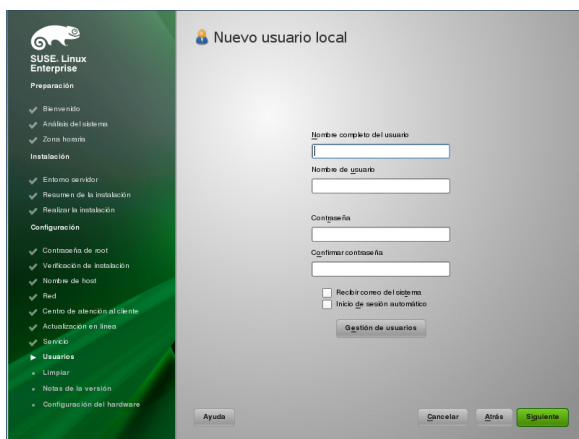
Haga clic en *Configurar más tarde* → *Siguiente* para omitir este paso y continuar con la instalación. Puede configurar esta opción una vez que se haya instalado el producto. Haga clic en *Siguiente*.



17. Por defecto, SUSE Linux Enterprise Server crea un certificado para el sistema. Para inhabilitar esta función, haga clic en *Omitir configuración* → *Siguiente*. Haga clic en *Siguiente*.

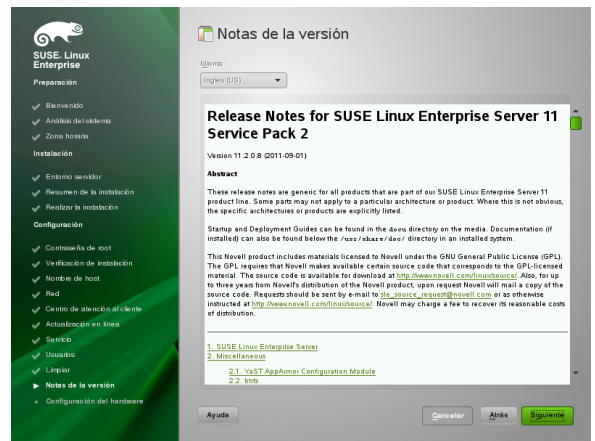


18. Seleccione *Local (/etc/passwd)* en la pantalla Método de autenticación de usuarios, a menos que el administrador del sistema le indique otra cosa. Haga clic en *Siguiente*.



19. Escriba su nombre y apellidos en el campo *Nombre completo del usuario*, especifique su nombre para entrar en el sistema en el campo *Nombre de usuario* y una contraseña (como le recomiende el administrador del sistema) en el campo *Contraseña*.

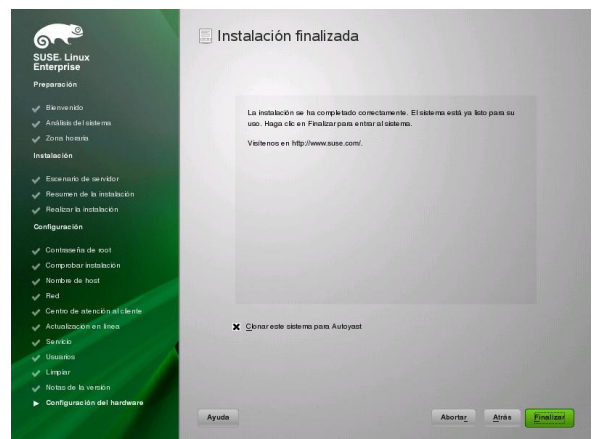
Por razones de seguridad, la contraseña debe contener un mínimo de ocho caracteres, entre los que deben figurar números y letras mayúsculas y minúsculas. Las contraseñas deben contener 72 caracteres como máximo; cabe recordar que distinguen entre mayúsculas y minúsculas. Haga clic en *Siguiente*.



20. Consulte las notas de la versión una vez que se haya efectuado la configuración del sistema. Haga clic en *Siguiente*.



21. Utilice la pantalla Configuración del hardware para ver o configurar la tarjeta gráfica y otros dispositivos de hardware. Haga clic en *Siguiente*.



22. En la pantalla Instalación finalizada, haga clic en *Finalizar* para terminar la instalación de SUSE Linux Enterprise Server y acceder a la pantalla de inicio de sesión.
23. Introduzca su nombre de usuario y escriba su contraseña en el campo *Contraseña*. A continuación, pulse Intro.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially.
